2 Minutes of the 140th Meeting of Council, held on 7 July 2011

Council approved the Minutes and the Chairman signed them as a true record.

3 Finance

Council noted an additional £250,000 had been received from the MOD towards the cost of the installation of air-conditioning plant at Stevenage.

Non-Public Account: Investments - The Honorary Financial Adviser recommended the bond fund should be moved.

4 Reports from Committee

Audit & Remuneration Committee: Performance-related pay - Council considered and approved the recommendations for the performance-related elements of staff pay.

National Army Museum Trading Limited: Council were briefed on the current outlook for NAMTL, its recent re-organisation, and the key areas of profit going forward. It was

agreed additional paperwork would be forwarded to Council Members so that they were in a better position to judge NAMTL's performance.

Acquisition and Disposal Committee: A report was made on the disposal of material to regimental museums, the introduction of computer bar-coding to improve the tracking of museum objects, and the development of the Museum's academic linkages.
